

## COVID-19 Policy for Culver City English Country Dance

*Please note that individual events may have stricter policies in place than those outlined here.*

In order to protect the health and safety of our dance community, attendees of any Culver City English Country Dance (CCECD) events must meet the following requirements before being allowed entrance into an event. Attendees must be:

- Pre-registered
- Free of key COVID-19 symptoms
- Wearing an appropriate mask (at all times when indoors)
- Fully vaccinated, with booster (if eligible)
- Signed the general and COVID-19 waivers
- Agree to the contact tracing policy

Additional details on each of those requirements are provided below.

### **Pre-Registration**

Advanced registration through our online form is required for attendance. This form can be found on the [culvercityecd.com](http://culvercityecd.com) website.

Pre-registration allows us to ensure all attendees are aware of and agree to the policies outlined in this document prior to arrival at the dance. Pre-registration enables us to collect the contact information necessary to conduct adequate contact-tracing measures. Registration will be limited to ensure that attendance does not exceed the capacity of the hall. This maximum capacity is determined by the CCECD Committee, considering the size of the hall and other risk factors.

Please register for dances individually. No “couples” registrations will be accepted.

### **Symptoms**

Upon arrival at each CCECD event, you will be asked to confirm that you have not exhibited any of the following symptoms within the previous 24 hours.

- Runny nose
- Headache
- Sneezing
- Sore throat
- Persistent cough

These are the top 5 symptoms exhibited by people who are fully vaccinated and contract COVID-19, per a COVID-19 symptom study out of King's College in England:

## **Masking**

All attendees are required to wear a face mask while indoors at a CCECD event. Please wear either an N95, KN95, or KF94 mask, or wear a surgical mask that securely covers the nose, mouth, and chin. Cloth masks alone will not be considered sufficient protection.

All food and drink consumption must be done outside; no unmasking indoors is allowed.

## **Vaccination**

A person is considered fully vaccinated 2 weeks after the final dose of a US-approved vaccine. A booster dose is also required, for those eligible. You can view your eligibility here: <https://www.cdc.gov/coronavirus/2019-ncov/vaccines/booster-shot.html>.

Proof of vaccination (fully vaccinated + booster) must be provided in person at the front door, along with a photo ID matching the vaccination documentation. The following are considered acceptable forms of proof: a physical vaccine card (or an electronic photo or physical copy of the same) or documentation of vaccination from a healthcare provider. A vaccine card must include the name of the person vaccinated, the type of vaccine provided, and the date of the last dose administered. Documentation from a healthcare provider must include the name of the person vaccinated and must confirm that they are fully vaccinated against COVID-19.

After presenting proof of vaccination at a CCECD event, an attendee can request that this information be recorded by a CCECD volunteer, so that proof of vaccination need not be supplied at future events. However, CCECD reserves the right to request proof of vaccination again, if necessary. Recorded information regarding proof of vaccination will not be shared by CCECD with other parties.

## **Waivers**

All attendees are required to sign both a COVID-19 waiver and a general liability waiver before attending a CCECD event. These documents will be provided during pre-registration and will also be available at CCECD events, at the front desk.

## **Contact Tracing**

All attendees are required to agree to the contact tracing policy before attending a CCECD event. This document will be provided during pre-registration and is available on our website, and it will also be available at CCECD events, at the front desk.

Anyone who becomes ill with symptoms of COVID-19 and tests positive for COVID-19 within 1 week of a CCECD event must notify the event organizer via text or email within 24 hours of receiving the positive result. The event coordinator will then initiate contact tracing so other participants can be warned of possible exposure to COVID-19.

It is highly encouraged for attendees to get tested if they exhibit symptoms of COVID-19 within 2 weeks of a CCECD event. The contact information for each event will be provided in the pre-registration form and included in the registration receipt email. Testing can be done with either a PCR or antigen test.
